

# Internal Laws of Biblical Interpretation

or How to Interpret the Bible

## Law #1

"All scripture is given by inspiration of God" (II Timothy 3:16). Since all Scripture is inspired of God (God breathed) all Scripture is of equal authority.

## Law #2

"All Scripture is given by inspiration of God *that the man of God may be perfect (fitted) thoroughly furnished* unto all good works" (II Timothy 3:16). This verse shows that the Bible student is completely furnished with what he needs, and this furnishing or out-fitting is the word of God.

## Law #3

"Study to show thyself *approved unto God, a workman* that needeth not to be ashamed, *rightly dividing* the word of truth" (II Timothy 2:15). Three things stand out in this verse. (a) "*Approved unto God*". This is your frame of mind as you approach the Word. You desire His approval as you read and study. (b) "*A workman*". You have to work at it. (c) "*Rightly dividing the Word of truth*". This indicates there must be careful attention to context so that each truth is placed in its proper place. Otherwise, Scriptures may appear contradictory.

## Law #4

"No prophesy of the scripture is of any private interpretation" (II Peter 1:20). Thus, if we would arrive at the proper interpretation we must consider all the scriptures on that subject. This is to say that 'a text without its context is a pretext'.

## Law #5

"...the dispensation of God which is given me (Paul) for you to *fulfil (complete, fill to the full so no more can be added)* the Word of God; even the mystery which has been hidden from ages and from generations, but is now manifest to His saints" (Col. 1:25,26). This 'mystery' was given to the Apostle Paul as the body of truth to *complete* the Word of God. Thus, there are no revelations from God since that time. This fact should cause the serious student of Biblical chronology to re-think the *internal* evidence of each book of the Bible as to when it was written, rather than accepting the traditions of men.

## Law #6

"...I am a man under authority, having soldiers under me; and I say to this man, 'Go', and he goeth, and to another 'Come', and he cometh; and to my servant, 'Do this', and he doeth it...". When Jesus heard it, he marvelled and said to them that followed, "Verily I say unto you, I have not found so great faith, no, not in Israel" (as this Roman Centurian has...) Matthew 8:8-10. Law #6 simply stated, is that all authority must be under authority. The Word of God is the *final* authority.

## Law #7

"Faith cometh by *hearing* and hearing by *the Word of God*" (Rom 10:17). Faith must rest on the Word of God, not the tradition of men, our experiences, etc.

## Law #8

"That you approve things that are (more) excellent" (Philippians 1:10). Literally, "to test the things that differ". We "test the things that differ" by comparing Scripture with Scripture.
